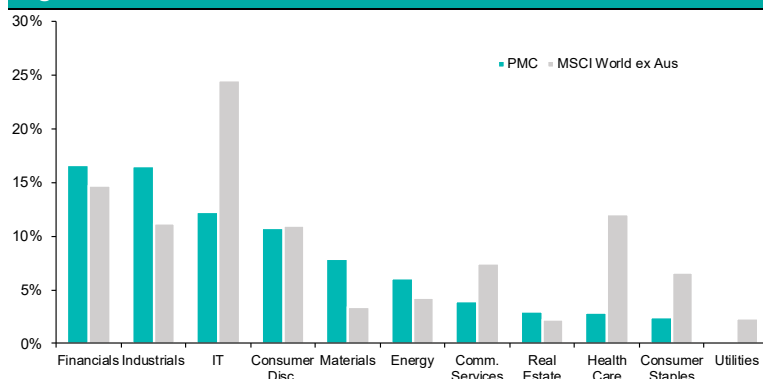

LIC Highlight

Platinum Capital Limited (PMC) invests in listed global companies with the LIC consisting of 70 to 140 securities which the manager identifies as undervalued. PMC took a cautious approach in 2023, leading to underperformance in the recent term as the portfolio remains defensively positioned taking a contrarian view. The manager seeks to allocate to opportunities in market turn-downs, with a tilt towards Asia and Europe, compared to the benchmark, with a larger allocation in China as they believe the market to be overlooked given recent regulatory scrutiny. The fund uses short positions to manage risk in the portfolio, making up 4.8% of invested capital, and projects an earnings yield over the next 12 months of 8.6% with a PE ratio of 11.6x.

The last reported post-tax NTA of PMC was \$1.56 representing a 14.9% discount to the last close price of \$1.31 per share. The discount is cyclically low, as highlighted in Figure 3, with PMC's discount ranging from -19.0% to 8.9% over the past 5 years indicating potential upside to investors. The company currently has 73m options outstanding, expiring on the 28th of March this year, with a strike price of \$1.37. Last year, PMC introduced an on market buy-back program to reduce market discounts and has provided investors with a consistent fully-franked dividend, achieving a gross yield of 6.4% over the last 12 months.

Figure 1 - PMC Sector Allocations vs MSCI World ex Aus



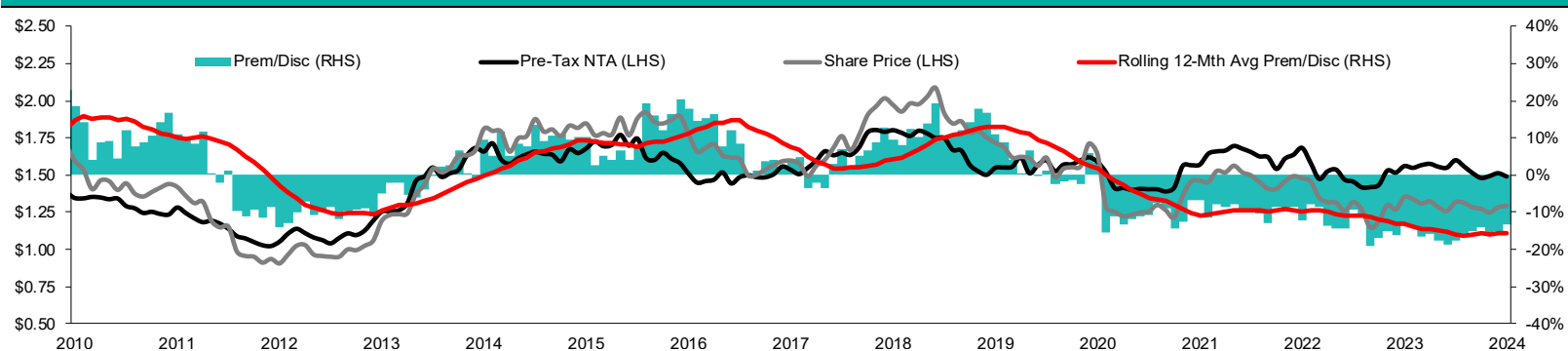

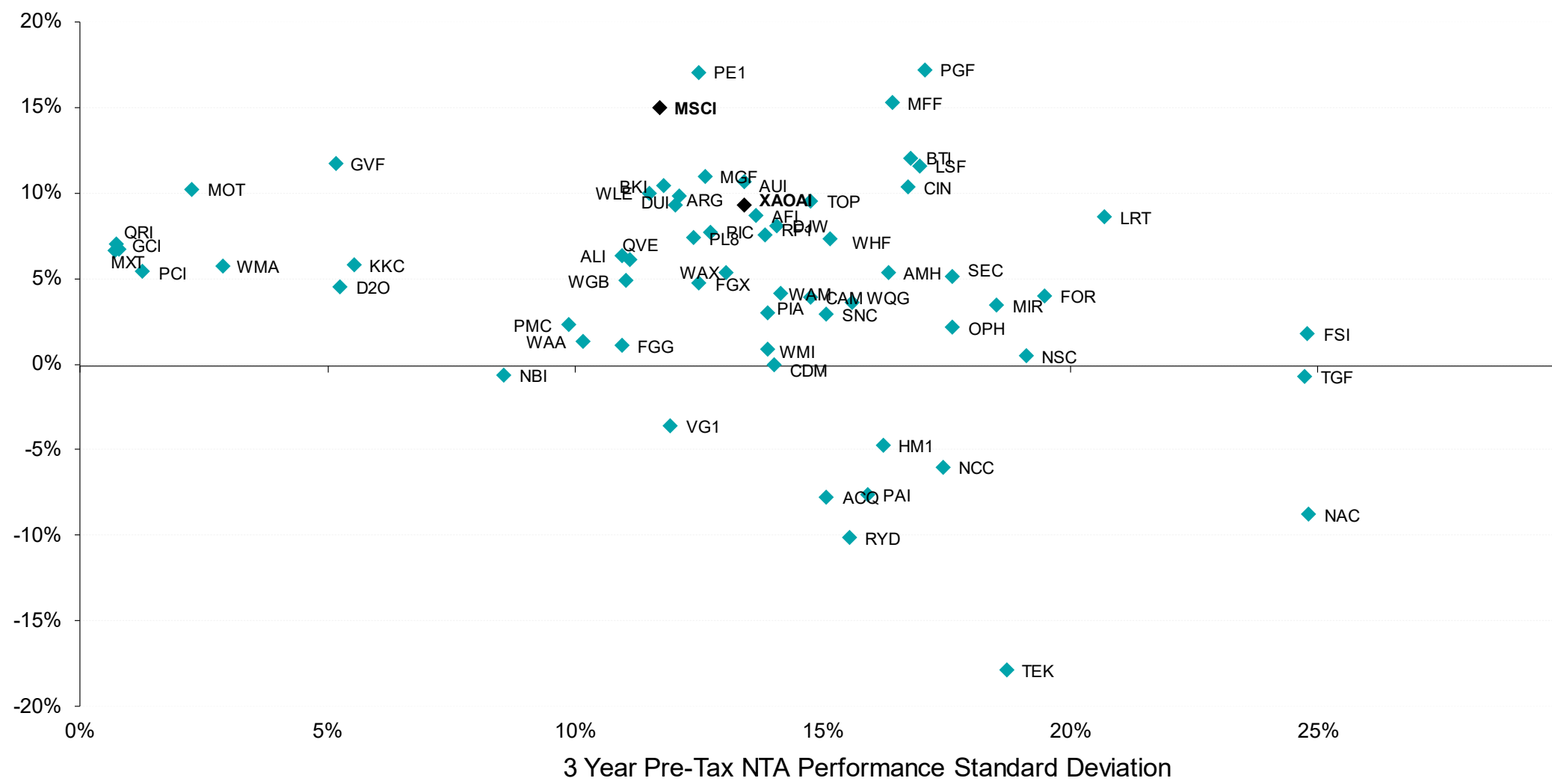

Chart 1: 3 Year Pre-Tax Performance v Standard Deviation



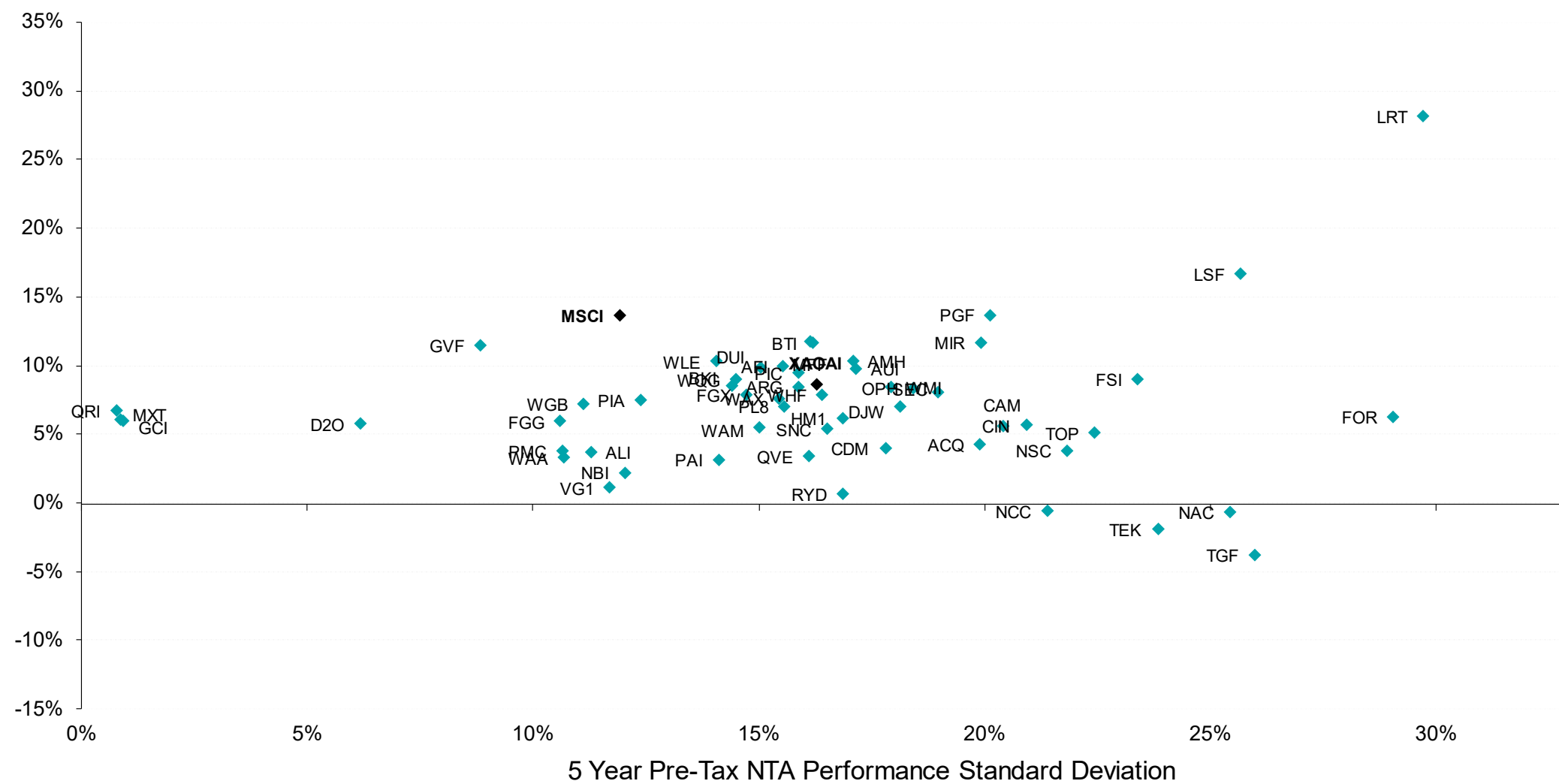

Chart 2: 5 Year Pre-Tax Performance v Standard Deviation



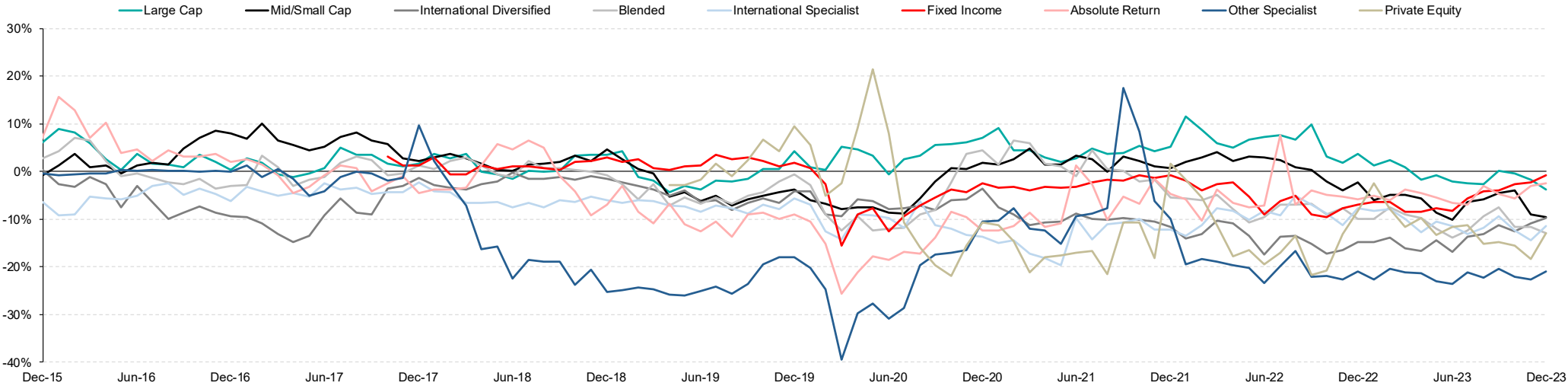

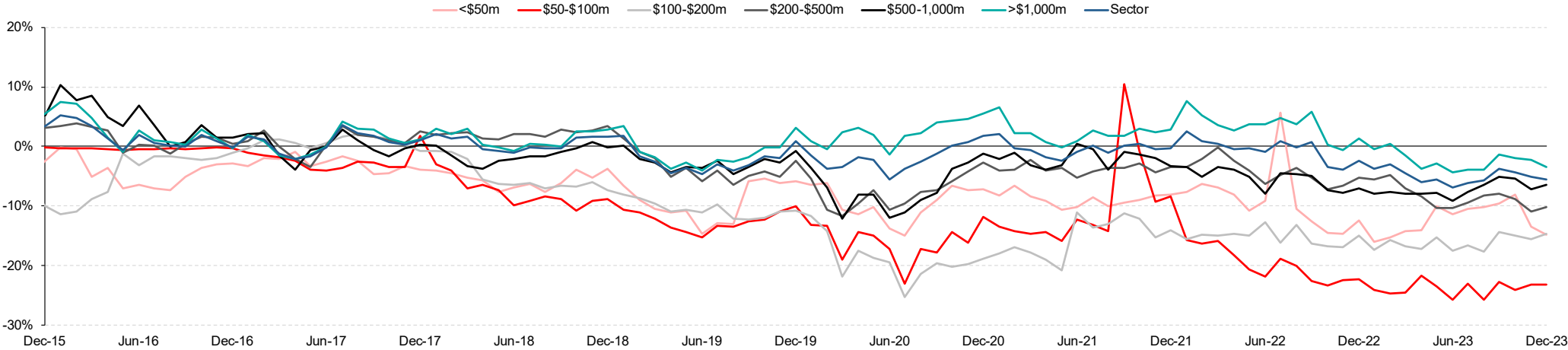

Chart 4: Premium/Discount by Market Capitalisation Band (Mkt Cap Weighted)

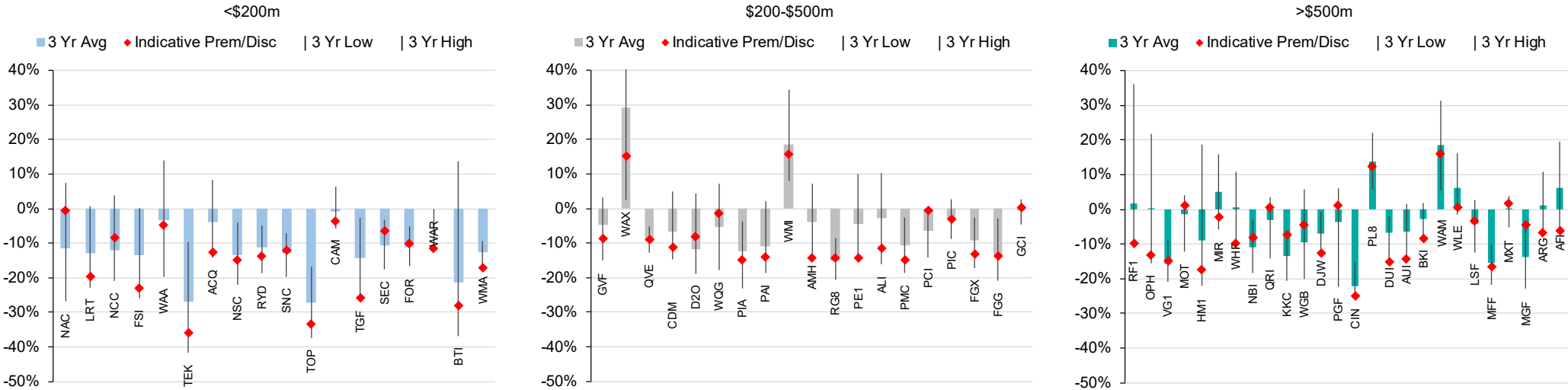

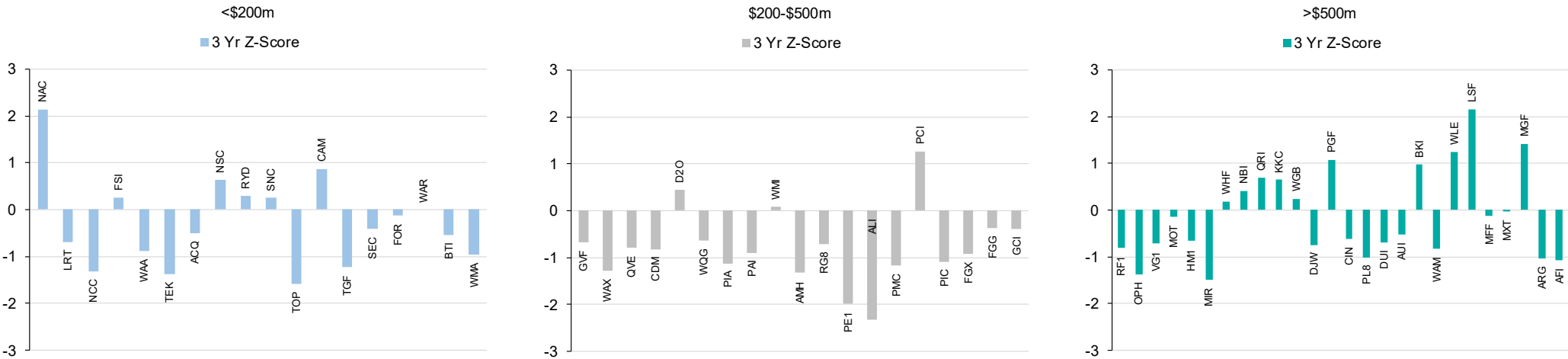

Chart 6: Standardised Premium/Discount by Variance Around Mean (Across Market Capitalisation Band)

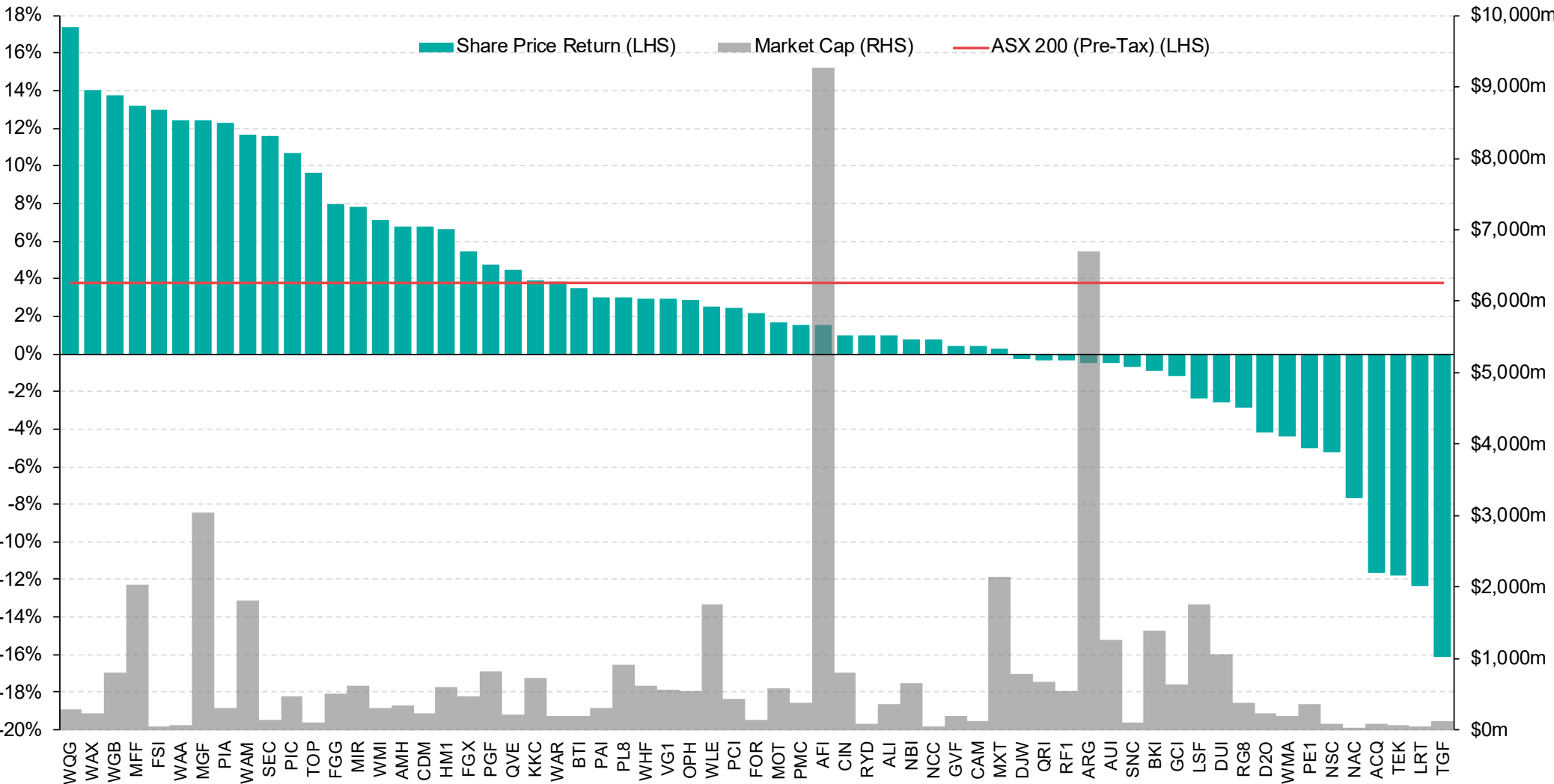
