

Weekly LIC Highlight

Djerriwarrh Investments Limited (DJW) offers investors access to enhanced yield through their LIC and is led by the quality team behind the Australian Foundation Investment Company (AFIC). DJW offers a yield uplift offer the S&P/ASX 200 Accum Index of 1.4% by incorporating call options in their portfolio, with coverage sitting between 30-40% of the book, sitting at ~39% currently, changing over time based on the managers market outlook. This is achieved without reducing the company's capital but instead driven mainly from Net Operating Profit, making the yield generated sustainable over the long term. The manager focuses on investing in high quality businesses and has a long investment horizon on the underlying portfolio, with low portfolio turnover, ensuring they operate in a tax efficient manner. Due to the size and scale of the LIC, Djerriwarrh is able to operate on a low management fee of 0.4% with no additional performance fees.

We currently calculate an Indicative NTA of \$3.36 per share for Djerriwarrh, trading at a 12.8% discount to the current share price of \$2.93. The discount reported is cyclically low for DJW, which has ranged between -11.6% and 11.6% over the last 5 years, resulting in a dividend yield of 5.1% (7.3% gross of franking credits). DJW has performed well, with growth in their pre-Tax NTA by 12.5% over the last year, and 8.3% per annum over the last 3 years, representing an attractive alternative to **Plato Income Maximiser (PL8)** which holds the same income focus, however its currently trading at a 9.7% premium to its NTA.

Figure 1 - DJW Sector Weighting





Chart 1: 3 Year Pre-Tax Performance v Standard Deviation






Chart 2: 5 Year Pre-Tax Performance v Standard Deviation



Chart 4: Premium/Discount by Market Capitalisation Band (Mkt Cap Weighted)





Chart 6: Standardised Premium/Discount by Variance Around Mean (Across Market Capitalisation Band)


