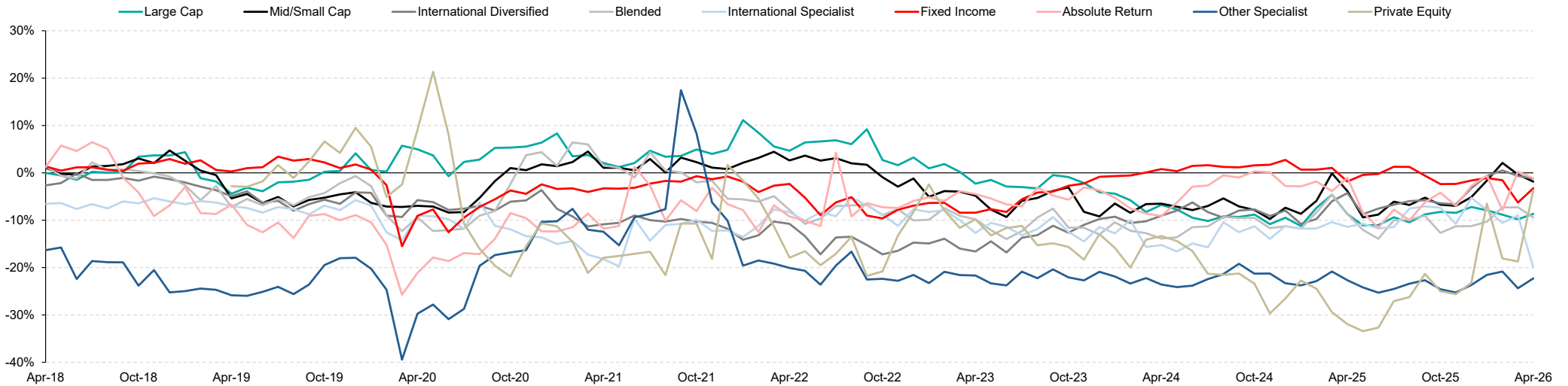

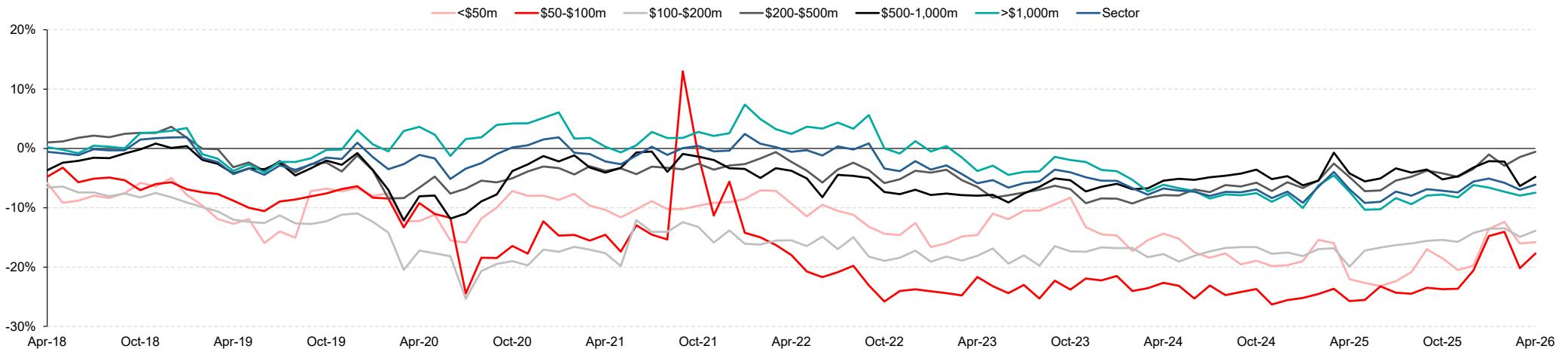

Chart 4: Premium/Discount by Market Capitalisation Band (Mkt Cap Weighted)

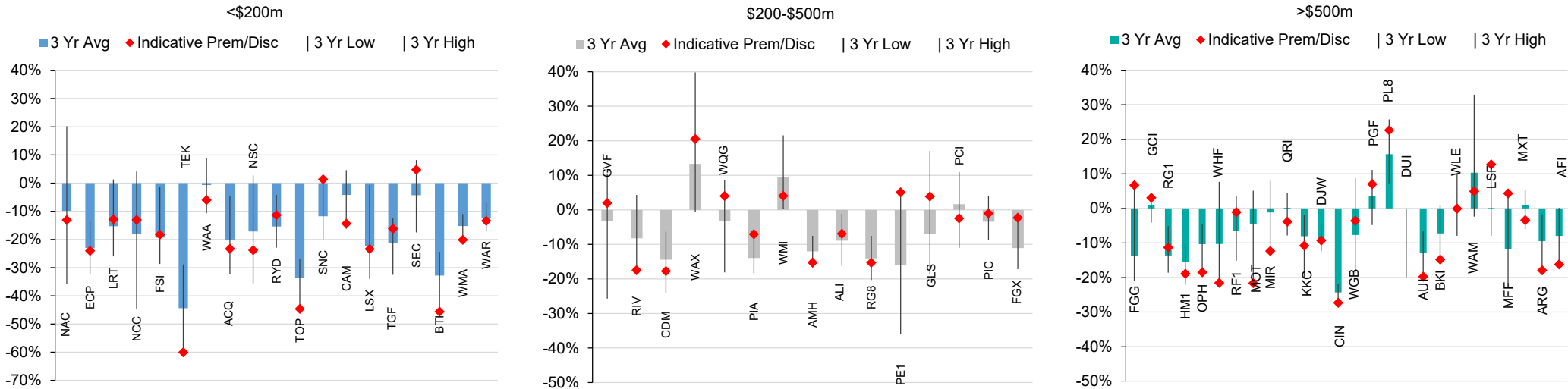

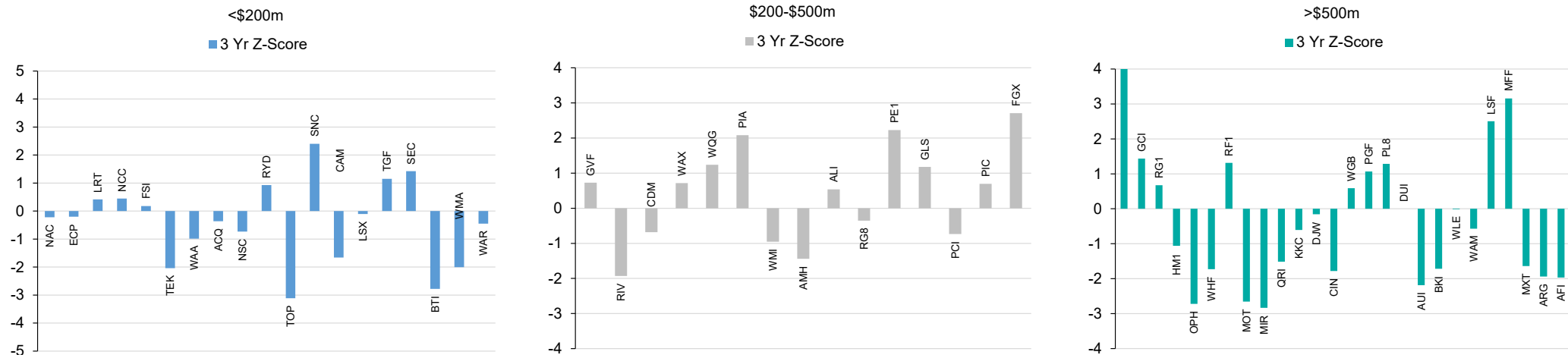

Chart 6: Standardised Premium/Discount by Variance Around Mean (Across Market Capitalisation Band)

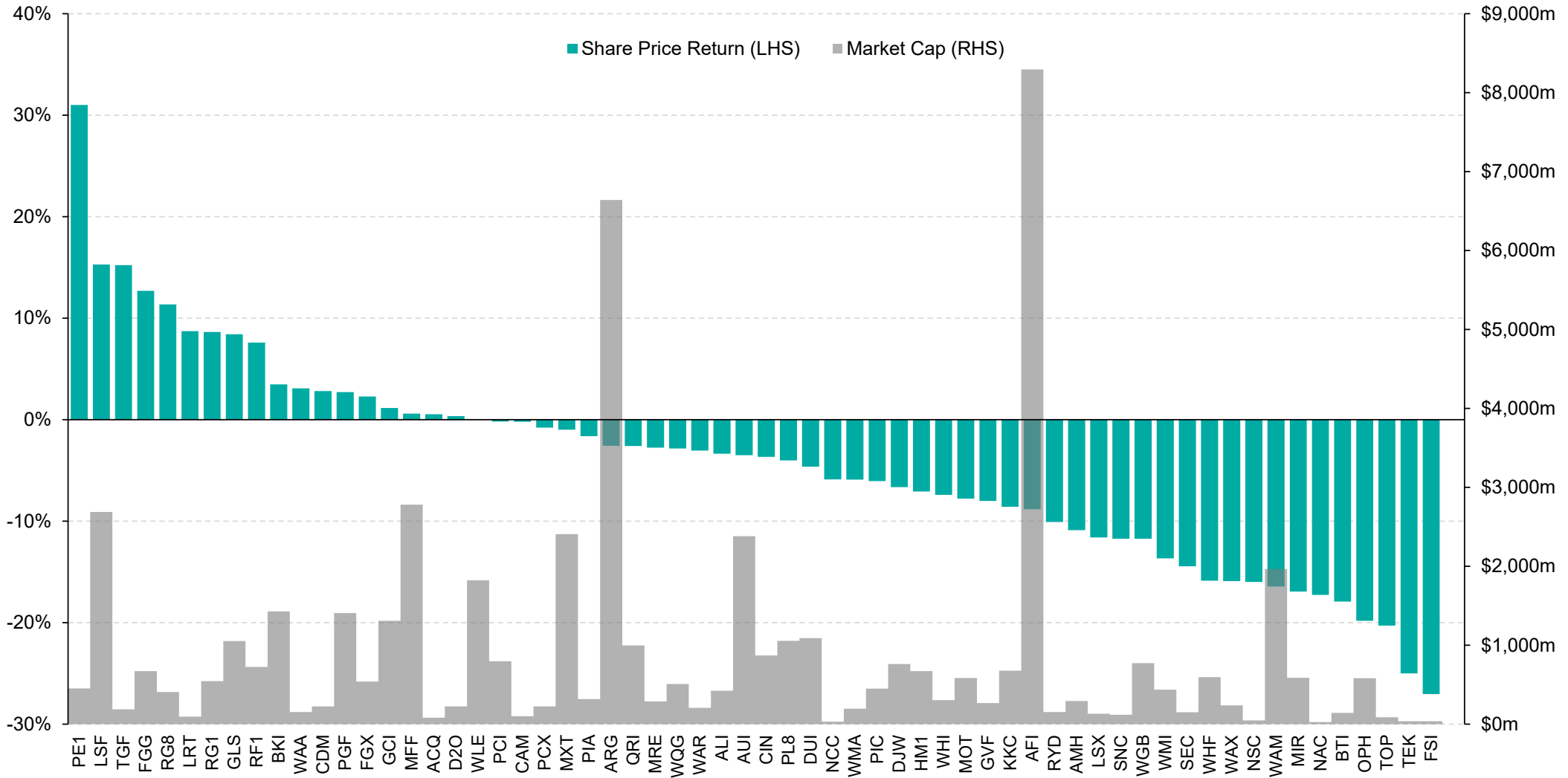
