NAOS Asset Management Spotlight

NAOS Asset Management is a specialist fund manager providing investors with exposure to high quality, undervalued, listed Australian micro, small and mid capitalisation companies, with an industrial bias in a concentrated structure.

On a pre-tax NTA basis, Naos Ex-50 Opportunities (NAC) was the second most successful medium/small cap mandate under Bell Potter coverage for the guarter ending 31 March 2021. NAC produced a return (including net dividends) of 10.7%, outperforming the benchmark S&P/ ASX 300 Industrials Accumulation Index by 6.0%. Meanwhile, Naos Small Cap Opportunities (NSC) emerged as the most successful small/micro cap mandate during this same time. NSC produced a return (incl. net dividends) of 18.0%, outperforming the benchmark S&P/ASX Small Ordinaries Accumulation Index by 15.9%. Despite significant excess returns, the share price to pre-tax NTA discount widened from 14.0% to 23.7% over the March quarter. Formerly known as Contango MicroCap, the longest running listed investment micro cap company on the ASX, then investment manager Contango Asset Management entered into a binding arrangement to assign the investment management mandate to NAOS Asset Management back in 2017. With the amended agreement also providing additional flexibility to hold onto performing positions, irrespective of the growth in size, the LIC has filled a niche within the NAOS suite that allows the manager to maintain compounding high conviction picks. Albeit, the discount has seemingly blown out since then.

With large spare capacity due to the recent recession, continued underlying sector performance, further alpha generation and discount compression could be imminent given position in the business cycle. March figures showed Australia's seasonally adjusted unemployment rate decreasing from 5.8% to 5.6% and monthly hours worked increasing from 1,762m to 1,800m month-on-month. An expected increase in GDP and income may translate to a general rise in the top-line for industrials and NAOS' investments. We see this as a catalyst for the share price, aided by expansionary monetary and fiscal policy.








