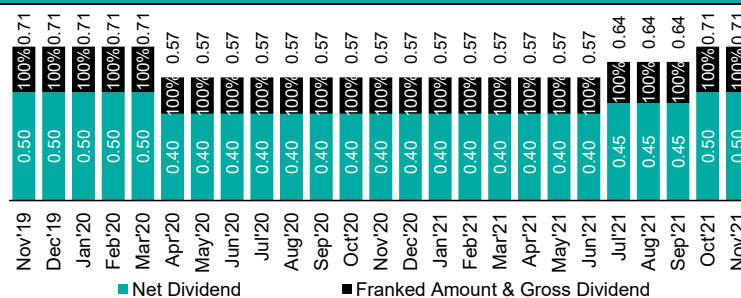
A philosophy for zero tax investors

Plato Income Maximiser (PL8), Australia's first and only LIC to pay monthly fully franked dividends, is providing the opportunity for eligible shareholders to acquire up to \$30,000 worth of new fully paid ordinary shares, with the subscription price equal to the lesser of \$1.11 (being the per share pre-tax net tangible asset value on 2 November 2021, the day before the Share Purchase Plan was announced) and the per share pre-tax net tangible asset (NTA) value on the day that the Share Purchase Plan (SPP) is listed to close (Friday 26th November 2021). New shares issued under the SPP will rank equally with those existing shares on issue and be entitled to the December monthly dividend. Application payments can be made via BPAY or EFT using reference numbers stated in the personalised application forms that were sent to shareholders on 5 November 2021.

The \$1.11 issue price (which was also offered to wholesale investors in the recent \$71.3m Placement) represents a 13.6% and 14.2% discount to the closing share price and five day volume weighted average price to 2 November 2021, respectively. While not NTA dilutive (as the Placement was conducted at the NTA backing per share), these events have most likely triggered recent share price softness, creating a unique buying opportunity both on market and via the SPP. PL8 shares have, on average over the past 12 months, traded at an 11.4% premium to the pre-tax NTA.

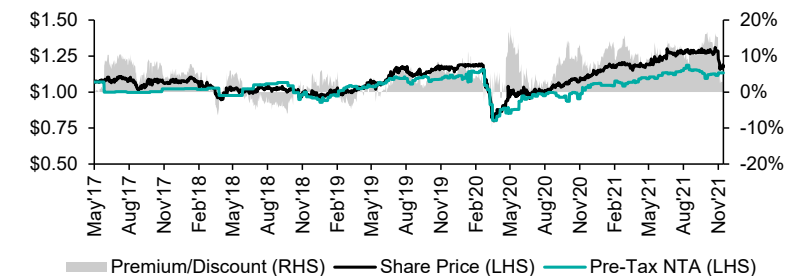
On 12 October 2021, the Board also resolved to pay three fully franked dividends of \$0.005 per share payable in October, November and December 2021. This represents an increase of 11.1% on the dividends paid during the September quarter, reflecting an improved dividend environment and signalling a return to normalcy before the COVID-19 induced dividend cuts that effected the Australian market. The consistent and regular fully franked income continues to be very attractive for zero tax investors, especially when considering the equivalent opportunity cost from subduced rates. RBA Governor Phil Lowe remains dovish on both wages and monetary policy.

Figure 1 - PL8 dividend history (cents per share)



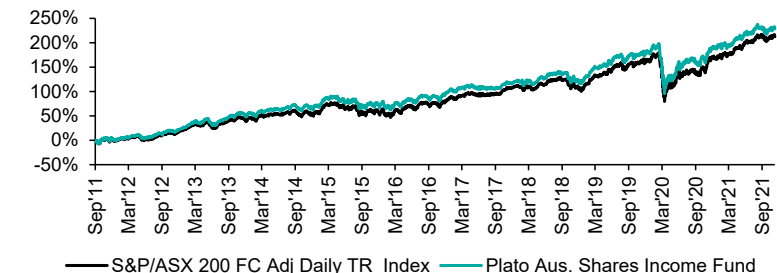

Figure 2 - PL8 price to NTA history and premium/discount



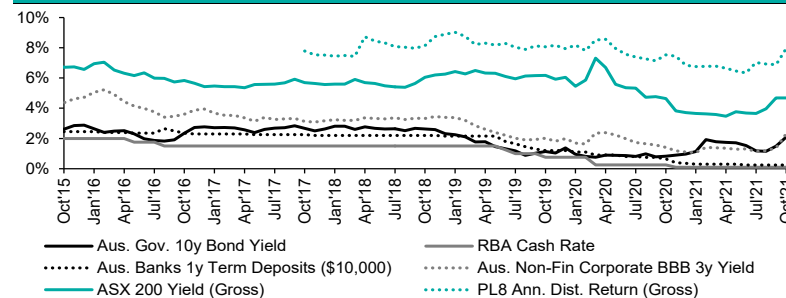

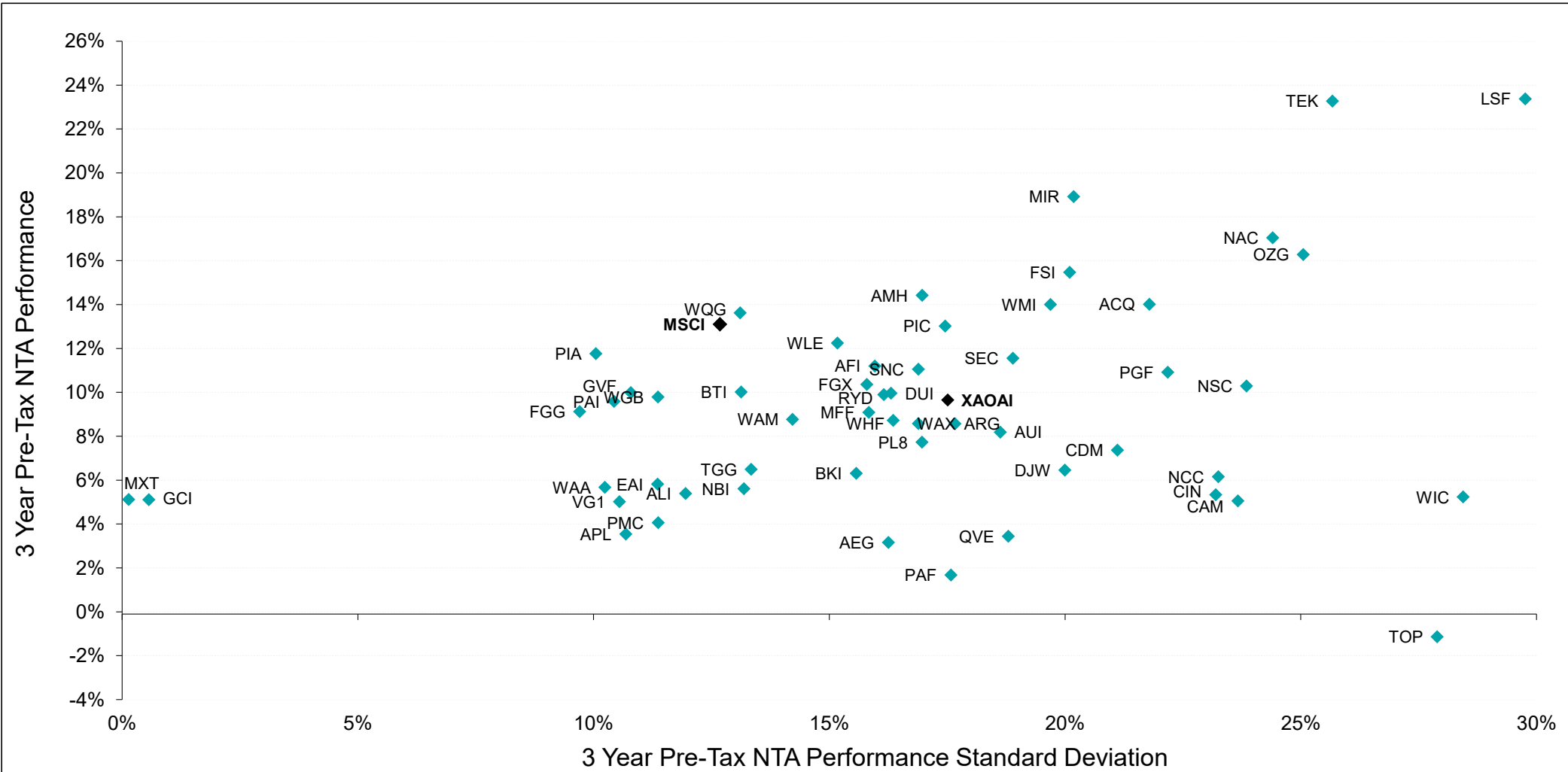

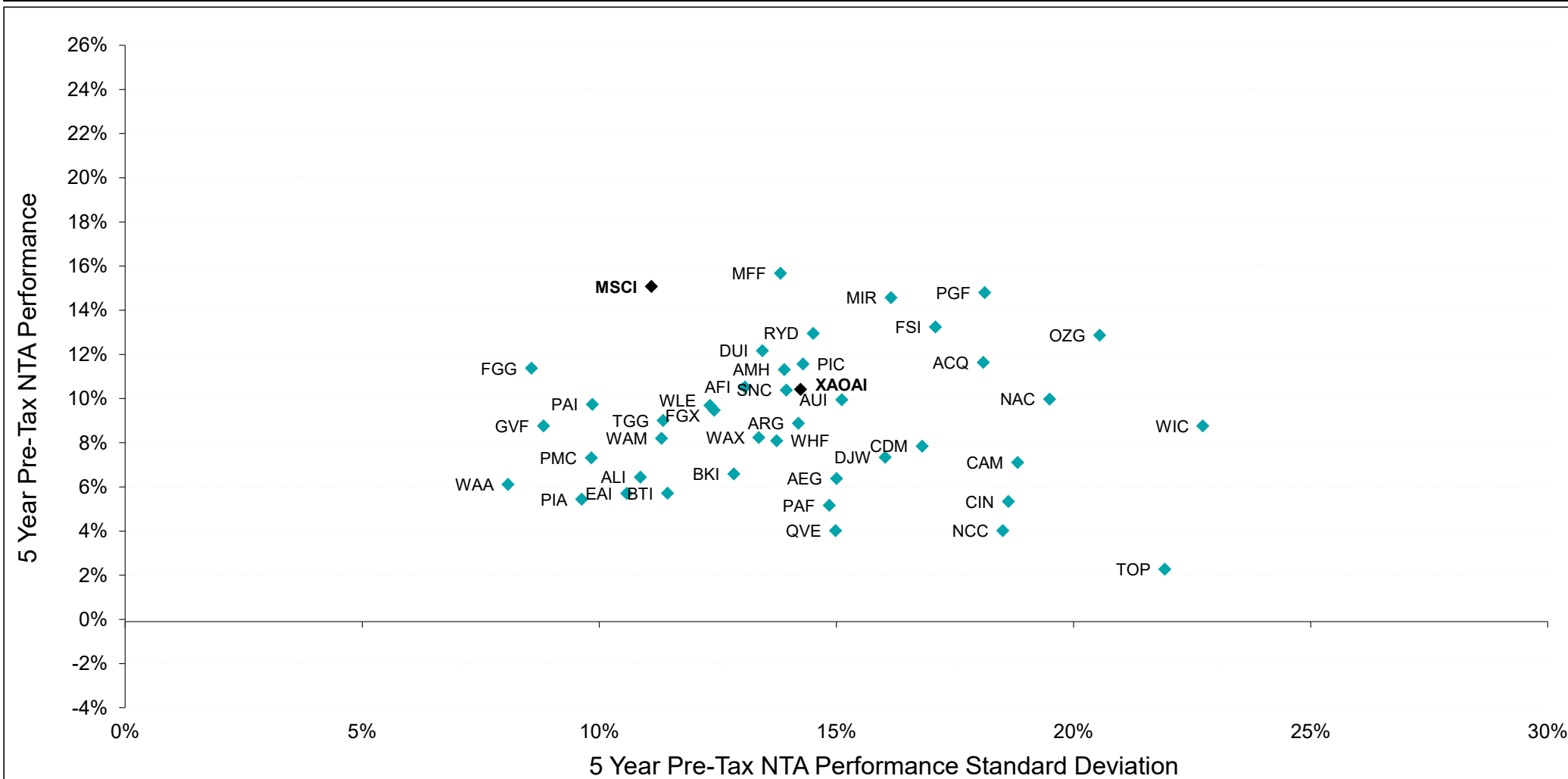
Chart 1: 3 Year Pre-Tax Performance v Standard Deviation

Chart 2: 5 Year Pre-Tax Performance v Standard Deviation

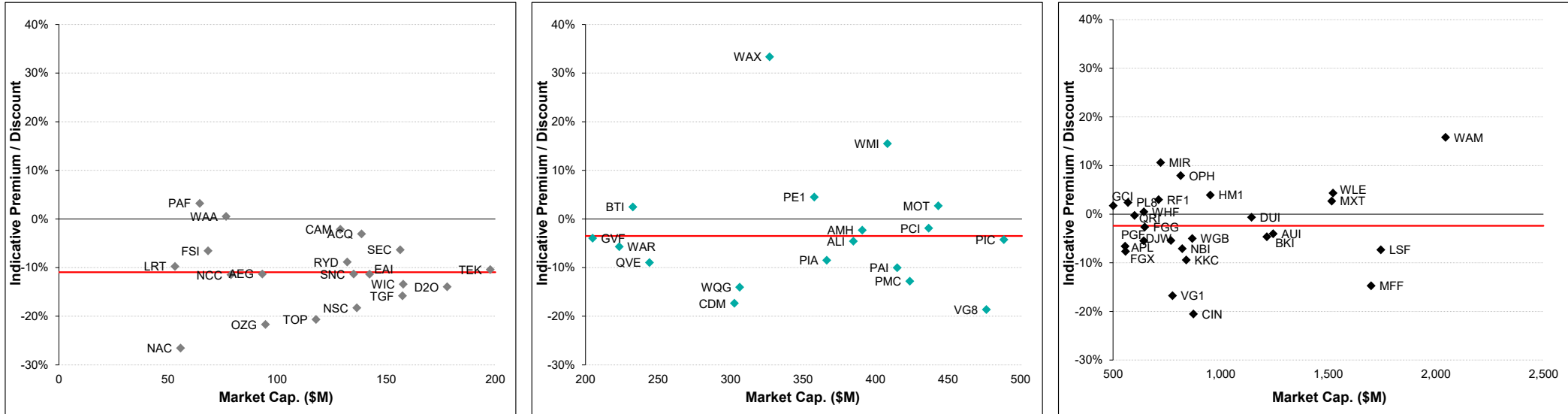

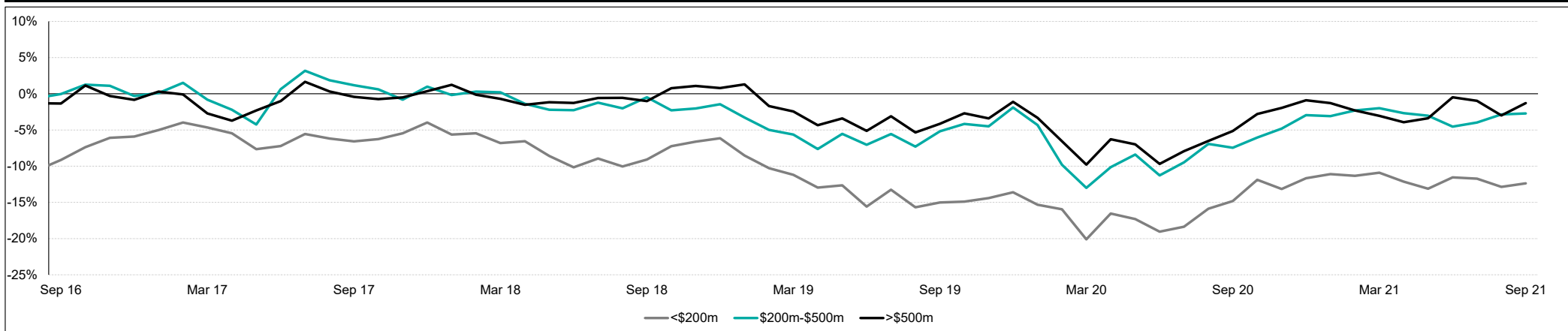


Chart 3: Premium/Discount Relationship Across Market Cap (Equal-Weighted Average Indicated by Red Line)



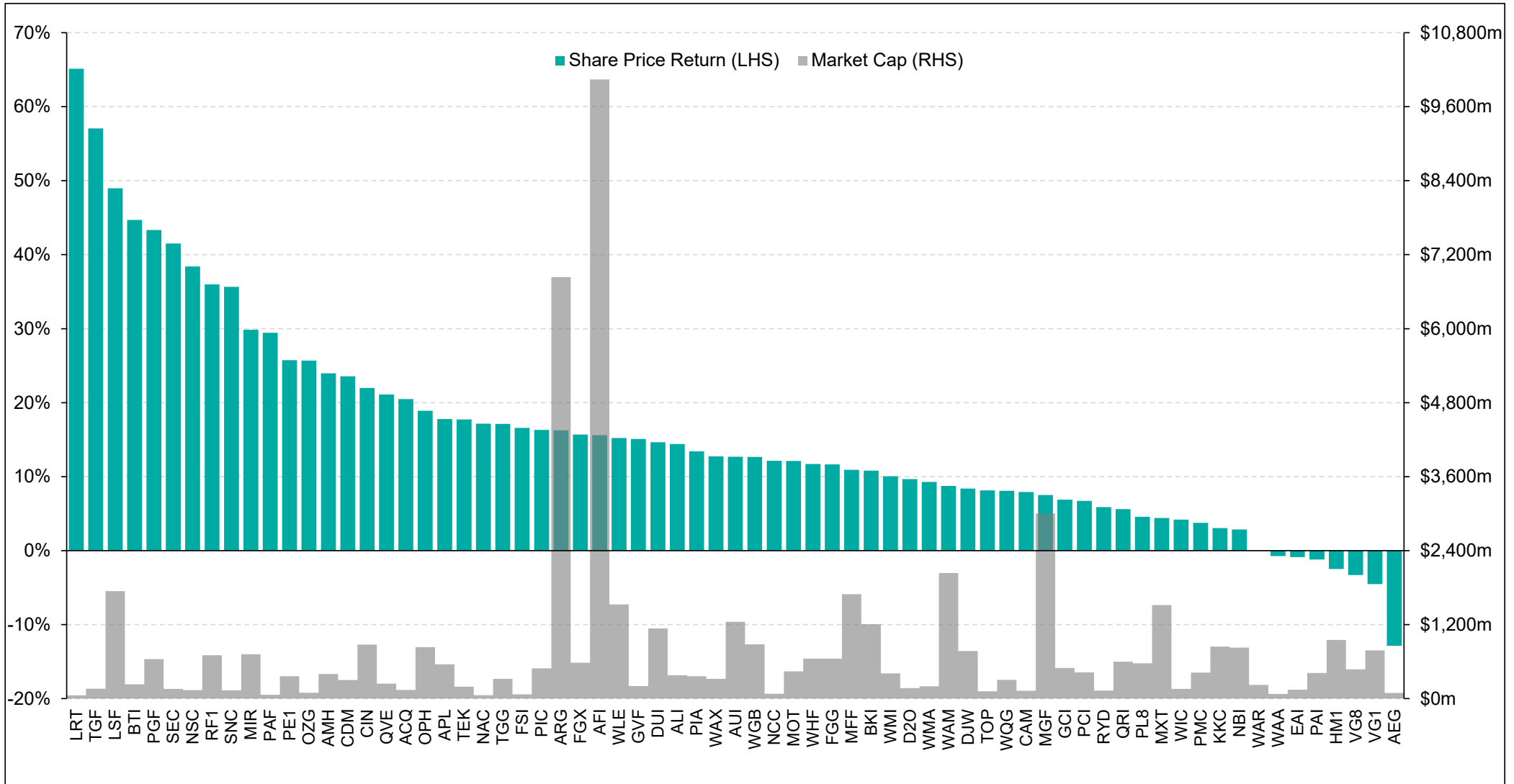
